#### **Purpose**

The NSW Outback Division of General Practice is a not for profit group that currently lease the Cobar Primary Health Care Centre. Their programs focus on early intervention, prevention of chronic disease, lifestyle modification and health promotion programs. They are responsible for recruiting doctors, nurses and other health professionals to work out of the Centre. They have been very successful in attracting a good range of services to Cobar and have plans to increase this further in the future.
